8. **Educational Qualifications**:

If any individual workedless than six months for COVID, the weightage shall be 0.83 marks per completed month will be awarded.
- e) Weightage to contract employment based on working area:
 - a. @ 2.5 marks per six months in Tribal Area.
 - b. @ 2.0 marks per six months in Rural Area.
 - c. @ 1.0 marks per six months in Urban Area.
 - d. No weightage will be given for the services less than six months.
 - e. Spells of service rendered will also be considered.
